#### UUC Board Meeting Minutes October 12, 2023

*In attendance:* Wayne Neu, Rev. Pam Philips, Fred Piercy, Laura Robinson, Rami Steinruck, Barbara Taylor, and Anna Tulou (via Zoom) *Guests:* Liz Craine, Dick Luke, and Jamie McReynolds

#### Chalice Lighting, Reading, Check-in and Review of Agenda

- Fred called the meeting to order at 7:00 pm and Rami shared a reading.
- The agenda was approved unanimously.

#### **Member Forum**

- Dick Luke and Jamie McReynolds were invited to share their experience with Capital Campaigns at UU organizations. In 2008, the NRV UUC successfully held a Capital Campaign and raised \$600,000 for expanding our building. It has been 15 years since our last Capital Campaign. When considering doing a Capital Campaign, here are recommendations based on our 2008 Capital Campaign and other UU congregations' experiences:
  - Know your goal. Clearly define why and what you are raising money for. It can be easier to do a Capital Campaign for a new building than to improve an existing building. You do not want to ask people for too little money. A capital campaign should be a minimum of \$500,000 and in the range of \$1 million - \$2 million. For example, what is 3-times the annual stewardship?
  - Survey your potential. Gauge the potential before you begin (you can survey without people making a commitment). Consider getting a consultant recommended by UU because outside experts can make a significant impact. NRV UUC hired an outside expert in 2008 and reached our goal. Please refer to the materials from the 2008 campaign.
  - **Create buy-In and enthusiasm.** Have a theme. It is very important to have good publicity. It is important to communicate that this is different from the annual stewardship campaign.
  - Have multiple strategies for asking. Decide how to canvas the members: mass group ask, small group asks, and one-on-one asks (which can be the hardest to do). Ask large givers independently and directly ask them for a large gift or to match gifts. For a potential large donor, ask early as this gift could be seed money or the lead pledge. This can be helpful because then we could say, "someone has already committed \$xx,xxx to this campaign" or "an anonymous donor has offered to match gifts up to a total of \$100,000". Allow people to self-identify as a potential large donor.
  - The Board will continue gathering information and exploring all options for financing the playground and other building improvements. These might include any of the following: a mini-campaign, using available funds, or planning for a capital campaign. The Board will discuss this further at their November meeting.

# Approve Consent Agenda

- Rami motioned to approve the consent agenda and Barbara seconded. The Board approved unanimously. These reports included the following:

- The Board discussed the Treasurer's Report. Wayne motioned to transfer funds out of obsolete Temporary Restricted Net Assets (TRNA) and reallocate so the congregation could utilize these funds in our current budget for 2023-2024. Laura seconded the motion and the Board unanimously passed. The following will be reallocated as such:
  - TRNA Mental Health Justice Ministry will be donated to NAMI.
  - TRNA Technology Fund will be reallocated to our 2023-2024 budget.
  - TRNA Coffee Donations will be reallocated to our 2023-2024 budget for Connections.
  - TRNA Poetry & Proses will be reallocated to our 2023-2024 budget for Connections.
  - TRNA Social Justice Projects will be reallocated to our 2023-2024 budget for Social Justice.
  - TRNA Grounds Donations will be reallocated to our 2023-2024 budget for Grounds.

## **Old Business**

- Fred provided a presentation on organizational structures and facilitated discussion. For the Board Meeting in November 2023, Fred will research organizational structures that connect mission and goals.
- Planning has started for this year's Isabel Berney Volunteer Award. In January 2024, the Board will begin soliciting nominations by forming a subcommittee. This subcommittee will review the nominations and recommend to the Board their choice for the recipient of the award at the March meeting of the Board, with hopes of the award being bestowed at the annual meeting.

#### **New Business**

- Liz Craine provided a presentation on the state of the UUC building. Please refer to the attachment "UUC State of the Building 2023". Wayne reports that the Finance Committee is working with Liz on prioritizing the building needs mentioned in Liz's report with the intention to seek board approval of them in the future.
- The Board praised Liz for her outstanding work on this and her dedication.
- The Board discussed ways to hear from committees and suggestions for enhancing communication. Committees report to Pam and Pam includes those in her report. The Board is also encouraged to read any minutes or annual reports submitted by the committees. Beyond that, Fred stated that he would like to invite committee chairs to make brief reports to the board from time to time. This will serve both to inform the

board of what committees are doing and to facilitate more direct communication and support to committees.

• The Board will offer "Dancing through the Decades" again this year at the service auction. Laura Robinson will be the point-of-contact for this event. The proposed date is Saturday, January 27, 2024, at 6 PM. The snow date would be the following Saturday in February.

# Leads Worship and Officiates Rites of Passage

The theme for September was the Gift of Welcome, and we explored what it might mean to be truly and radically hospitable as a congregation. Ministerial intern Anna Tulou invited us to turn our focus outward, considering how we might minister to and with the community. The theme for October is the Gift of Heritage, which will give us the opportunity to explore our Unitarian, Universalist, Unitarian Universalist, and UUC heritage.

I've been more intentional about collaborating with the choir director and pianist so that the music is more integrated with the rest of the service's elements. Jared has been a great collaborator, choosing music that supports the themes of worship. We have also begun experimenting with musical reflections after the service.

The worship associates will be meeting on the afternoon of October 29th for a retreat.

Ministerial intern Anna Tulou led a memorial service for a congregant's family member. The local Good Samaritan Hospice held a service in our sanctuary for families they have served over the last year that was lovely and included releasing doves outside.

## Provides Pastoral Care and Presence

I continue to meet with individuals at their homes, in health care facilities, and at UUC. There have been no requests for friendly visits, so I'll be identifying people who might benefit from visits and share that with the volunteers. The Lay Pastoral Care Ministry continues to meet people's needs as well.

I continue to meet with the Surviving Spouses group, which we have opened to people who do not (yet) attend UUC. I also meet with the Sages group when I am able.

## Encourages Spiritual Development for Self and Others

The Soul Matters groups have formed and begun meeting. We have 6 groups with 39 people in them, with both in-person and Zoom meetings. We are also offering a morning group for the first time. I continue to meet with the Conversations on our Faith group on Wednesday afternoons. It was good to read the same book (*Dangerous Religious Ideas*) that we read with the Interfaith Book group, which 3-4 UUC members have also attended.

## Witnesses to Social Justice in the Public Square

I met with the Environmental Justice Team and am looking forward to their getting more of the congregation involved in activities.

I created web pages for the Voter Rights and Reproductive Justice teams on our web page.

The NAACP religious affairs committee is sponsoring an October 30<sup>th</sup> event at the Church on Main with Dr. Sylvester Johnson speaking on bridging the gap between politics and religion.

## Leads Administration

I met with Nancy Bodenhorn to discuss possible members of the new Conflict Transformation Team, and she is currently pulling together a team that will help draft a charge for the team. She is also planning to take a UU Institute training on Right Relationships Teams to help them get started.

I met with the Connections Committee and discussed doing "Widening the Circle" training for greeters and other members of the congregation to help us become more welcoming to all people. We will be holding a Newcomers Orientation on November 11<sup>th</sup> and would like to have a board member attend.

Likewise, we discussed having a Visitors Table in Elarth on 3<sup>rd</sup> and 4<sup>th</sup> Sundays where people can meet for New to UUC conversations and to get a tour of the building.

The Committee on Ministries has begun soliciting input for my evaluation and looks forward to holding feedback circles on the Grounds Ministry this fall. We welcome George Lally to the committee.

The new Grounds Ministry co-chairs, Amanda Morgan and Valerie Bidwell, have gotten off to a great start and will be holding their first Sunday workday during/after the Second Sunday potluck. The annual Fall Put-the-Grounds-to-Bed workday will be on November 4<sup>th</sup>, and I encourage board members to participate.

It was a joy to welcome Ericka Kelly back from family leave. We have enjoyed having her son join us for staff meetings. In addition to her time in the office on Tuesdays, she will work two Sunday's a month at UUC. The other Sunday's and Thursday's she will work from home.

I look forward to our first Stewardship meeting this Sunday, with new chair Mary Ann Hansen leading us.

# **Children and Youth Programs:**
