Annual meeting (Bylaws Article V)

An Annual Congregational Meeting shall be held each year between March 22 and June 15. The Congregation at this meeting shall elect new officers, adopt the Congregation budget, and conduct other such business as the Board may designate. The President shall serve as Presiding Officer.

The Board shall publicize the time, date, and purpose of any Congregational Meeting by mailing or emailing a notice at Congregation expense to all members at least two weeks in advance of the meeting date.

Not less than one week before a Congregational Meeting, except one called solely for the purpose of an election, the Board shall convene an informational meeting for the Congregation at which issue(s) on the agenda of the upcoming Meeting are presented for discussion. No votes or parliamentary motions shall be entertained at informational meetings.
