### Unitarian Universalist Congregation Board Meeting Minutes April 14, 2016

**Present**: Board members Bill Baker, Tim Pickering, Bob Stimson, Carol Kern, Linda Powers, Molly Lazar; ex officio members Dara Olandt, Karen Hager, Lisa Evanylo

Carol lit the chalice, and Dara provided the reading. All checked in. Bill served as Process Observer (PO).

- I. **Member's forum –** no members in attendance
- II. Agenda Tim moved to accept the amended agenda. The motion carried unanimously.
- III. **Board development** see attached draft of "How Our Congregation Works". An update was given on the ad hoc Governance Committee's (Jim Flowers, Kristine Reid, Molly Lazar, Frank DuPont, Stephanie Gilmore, and Dara) work on our new governance structure. Some suggestions from the committee are: 1) do away with Board liaison roles, 2) remove the Governance Council and change to Governance Oversight Committee that meets as needed, 3) remove Denominational Affairs, 4) start a Church Operations Council for dealing with day-to-day functions and facilities issues, and 5) change the role of Board President to include an active 2-year term with the 3<sup>rd</sup> year being a supportive role for the president, attending 1 Board meeting per quarter.

### IV. **Staff Reports** – see written reports

- A. **Minister's report** Dara mentioned the upcoming Sundae Sunday, and that there might be a role for the Board in the service. Hopefully all can attend. April 30 is the workshop in Waynesboro. Dara will not be at the May Board meeting.
- B. **DLFD report** Karen stated that RE is winding down with just 6 Sundays left. She is heavily into recruiting for next year. She asked the Board to support the YRUU concert fundraiser on May 7.
- C. **Administrator's report** Lisa will be attending the cluster gathering on April 30 and will work with Karen and Ann Norris to plan the ice cream sundae stewardship celebration.
- V. **Consent Agenda** Bob moved to accept the minutes from March. The motion carried unanimously.
- VI. **Approval of alternate delegate for GA** Bob moved to approve Kim Feucht as an alternate delegate to GA, if needed. The motion carried unanimously.
- VII. **Treasurer's report** written report attached. Linda stated a tablet has been ordered for use with our Vanco credit card swipe. Bill Baker is acting Finance Committee chair until June 30 as our 2 co-chairs resigned.

### IX. Action Items

- A. **UUA presidential run** Dara previously emailed a request to approve the nomination of 2 additional candidates for UUA president. However, Susan F. Gray has already received the needed 25 signatures to get on the ballot. The other candidate needing signatures is Jeanne Pupke. Carol moved to endorse both candidates. The motion carried unanimously.
- B. **Targeted donations** a member has offered to donate \$5000 to pay down member loans, and another member wishes to donate \$600 for grounds. Tim moved to approve both donations. The motion carried unanimously.
- C. **Singles dance at UUC** UUC friend John Pettigrew requested holding a 50's vinyl singles dance in Elarth. It was suggested that he contact Annie Dornberg of our new 50+ singles group which is being sponsored by our Connection Committee.

### X. New Business

- A. **Transition discussion** Molly and Dara spoke with Keith Kron of the UUA, and the Transition Team met April 13. The team consists of Isabel Berney, Molly Lazar, George Lally, Patrick Feucht, and Mark Benson (approved to replace Margo Walter). Keith stated that we are in a good position for a 1-year interim although the pool is smaller as most ministers prefer a 2-year placement. Molly requested permission to initiate putting together our ministerial search team with 5-7 members. Barbara Taylor and Avi Shroff have already expressed interest in serving. An article will appear in the May newsletter asking for volunteers. All should send suggested names to Carol to bring to LDC. The Search Committee members will be voted on at the June 5 annual meeting. Bob moved to call an interim minister. The motion carried unanimously. Bob moved to offer a 1-year interim position. The motion carried unanimously. Linda suggested using the surplus from this year's budget to help pay for moving the interim and for the search.
- B. **Budget priorities** Bob compiled the results of the paired comparison analysis rankings done by all Board members prior to the meeting. See attached ranking. Linda will email the results to the Finance and Stewardship Committees. Finance is meeting on May 4 and can match pledges to priorities.
- C. **Stewardship update** to date \$60,000 has been pledged from 24 pledging units. People seem to be enjoying the one-on-one visits. If the goal is not reached, the Stewardship Committee feels strongly that we do not ask donors to give more but that we match the budget with total income. Those who don't get their pledges in will be called. Board members agreed that the stewardship materials are excellent.
- XI. **Information items/timeline** Sundae Sunday is April 24, cluster gathering is April 30. There was good attendance from UUC at the anti-violence service last Friday night in Christiansburg.
- XII. **Process Observer** Bill stated that Molly wisely moved through the initial part of the meeting quickly to leave time for other important business.
- XIII. **Next meeting May 12 at 7 PM** Bill will provide refreshments, Linda will serve as PO, and Tim will provide the closing reading.

Bill provided the closing reading.





#### This month:

- The Adult RE Building Bridges class continues this month with discussions on Humanism, Atheism and Agnosticism; and Paganism and Indigenous Religions. We finish next month with a discussion on Unitarian Universalism.
- OWL 8-9 finishes this month with a lock-in. Classes are held downstairs, and signs are posted to inform those in the building that only those affiliated with the class are allowed on the lower level during class time, due to the class content. This information has also been included in the weekly LFD email newsletter during class weeks. To date, there have been no complaints about this arrangement.
- YRUU attended Mountain CON last weekend, with 8 youth attending.
- LFD Volunteer Appreciation events will be held on April 30 and May 1 this year for our teachers and youth group advisors. Those with children will be offered a childcare event; children are dropped off and we feed them dinner, provide childcare, and a movie and activities for the kids, so the parents can go out alone and have fun. This is a very popular event! It can, however, be difficult to staff with childcare volunteers, and efforts are underway to recruit. Rachel heads up planning for this event, and the Women's Breakfast Group has generously volunteered to provide food. For those without children (or those that cannot attend the childcare event), we will be treating our volunteers to lunch out at India Garden on May 1. These two events are a long-time tradition and are greatly appreciated by our volunteers that put significant hours into the LFD program.
- YRUU is planning a concert for May 7 that will feature performances by our talented kids some of whom are graduating this year and (I think) our very talented advisor, Willie Caldwell. This is a fundraiser for next year's Boston trip. Please put the date on your calendars now and plan to support our kids.
- Recruitment efforts are in progress for summer and fall. Summer RE begins June 12; our goal is to finish recruitment by April 30. For fall recruitment, we aim to finish by Memorial Day.
- My time is now being spent wrapping up the year and beginning plans for next year. Rachel's hours will primarily be going toward recruitment, with me assisting her efforts.

## **How Our Congregation Works**

And where you might find a place to connect...

## History...

In 2012 the Board and Congregation approved revisions to our system of governance to make it better suited to a congregation of our then current and future size.

Those changes distributed significant operational autonomy to eight councils and re-defined the role of the Board as a policy-making body, rather than a management group. These councils are now in place, but were expected to evolve over time, as our needs and resources change.

The timing is now right for some additional tweaks to the system. This slide deck describes the next, but not the final, version of our governance structure.

## The big picture...

The pages that follow show how all the pieces fit together, from the congregation as a whole, through the elected Board, the councils, and the various committees.

There are three main segments:

- 1. What might be called the "government"
- 2. Congregational operations the nuts and bolts
- 3. Congregational ministries what we are all about

## Government...

The congregation as a whole makes six really important decisions.

- 1. It adopts governing By-Laws.
- 2. It elects an Executive Board.
- 3. It calls a Minister.
- 4. It creates and lives by statements of Mission and Covenant.
- 5. It elects Trustees to "own" property in the name of the congregation.
- 6. It adopts the annual congregational budget.

## The Executive Board...

The Executive Board has five principal functions.

- It is the overall custodian of the congregation's mission and vision, charged to uplift that mission in all decision-making on behalf of the congregation.
- 2. It manages adherence to provisions of the By-Laws, such as annual meetings.
- It considers and ratifies the formal policies by which the organization is governed on an ongoing basis.
- 4. It ratifies the selection of members for some committees.
- It takes all personnel actions, such as hiring, firing, and compensation.

## **Board Members...**

Three members of the Board are the annually elected officers of the congregation:

- President-Elect
- President
- Past-President

To hold the "office of the president" is normally a three year commitment for an individual, with a different area of focus in each year: membership development, current operations, and, finally, mentorship of the incoming President-Elect.

One member, the Treasurer, is elected every two years.

The other four members of the Board are elected at-large to overlapping two year terms.

## The Executive Committee...

The four officers of the congregation serve also as an Executive Committee.

This group sets and publishes the agenda in advance of each Board meeting.

Our By-Laws specify use of Sturgis's Standard Code of Parliamentary Procedure. Under that code, the Executive Committee may be authorized to act with Board power, if necessary, between meetings, within appropriate limitations.

## Professional Staff...

All our professional staff are directly supervised on a daily basis by the Minister, though execution of formal personnel actions are reserved to the Board, subject to the advice and counsel of the Minister.

## The Councils...

Two councils, the Program Council and the Operations Council review action plans for policy compliance and coordination among their various committees.

Each council has a minimum of three members, with the non-staff members selected by and empowered by the committees and action teams that fall under its purview. Typically, each committee chair would sit on its council, but that is not required.

Each council selects its own chair.

## **Our Ministries**

The spiritual and humanitarian work of the congregation is charged to the Program Council and has four principal components.

- Lifespan Faith Development
- Worship Support
- Social Action
- Pastoral Services

## Operations

The day-to-day functioning of the congregation is charged to the Operations Council. Key components of the council are:

- Finance & Administration
- Facilities
- Membership Activities

## Assessment and Change

There are four important functions that are charged to committees that fall outside the two main branches of our organization.


Strategic Planning Committee – enabling the creation of our mission, vision, and covenant documents, and helping us execute long-term commitments.

Governance Oversight – checking out how our system is working and recommending changes that will keep us running smoothly.

Leadership Development - helps identify, recruit, and enable candidates for important positions, such as officers, board, and standing committees.
